SENTENCE ADMINISTRATION PROCEDURES MANUAL

POLICY OVERVIEW

Offenders may only be received into the custody of Corrective Services NSW if an appropriate order has been issued by an authorised agency.

The order that is generally issued is a warrant, committing the offender to custody. Each warrant or order must be addressed to Corrective Services NSW and outline the reason for the person's detention and it's duration as well other essential items of information.

Corrective Services NSW is responsible for enforcing the intent of the order or warrant.

Sentence Administration staff are responsible for interpreting such orders and warrants and recording their details accordingly to ensure Corrective Services NSW fulfils its obligations to the Criminal Justice System.

PURPOSE

This procedural guide outlines the role of staff in making determinations as to the legality of various orders and detainers issued by appropriate authorities, specifically in relation to the admission and detention of offenders.

It further specifies how to interpret and record such orders to ensure Corrective Services NSW complies with them.

SCOPE

This policy applies to all staff and contractors managing offenders in New South Wales.
