Housing Pathways



On 27 April 2010, a new program called Housing Pathways will make it simpler, fairer and easier for people to apply for and be matched with housing assistance.

At the moment, if you apply for housing assistance, you have to lodge an application with Housing NSW and community housing providers. Each organisation has their own waiting list and if you want to change your details or find out where your application is up to, you need to contact each organisation.

To make this process easier and fairer, Housing NSW, 28 community housing providers and the Aboriginal Housing Office have worked together to set up one application system under Housing Pathways.

From April, you will be able to fill out a single application form to apply for housing owned by Housing NSW, participating community housing providers or Aboriginal housing owned by the Aboriginal Housing Office.

You will be able to choose who you would like to provide housing assistance to you and, depending on who you selected, you may get an offer of housing from either Housing NSW, a community housing provider or the Aboriginal Housing Office.

A single statewide waiting list called the NSW Housing Register will also be created. This register will include all clients on the Housing NSW waiting list and participating community housing provider waiting lists.

The same as you can currently go to any Housing NSW office, you will be able to visit or contact any of the offices owned by these participating organisations and find out where your application is up to as all participating housing providers can all access the same system.

What is a community housing provider and how is this different to Housing NSW?

Community housing provides affordable rental housing to around 18,000 households on low to moderate incomes across NSW. The NSW Government has made a commitment to grow community housing so there are 30,000 homes by 2016. This means you will have more choice to apply for housing with different providers and through Housing Pathways, you will be able to do this through one application process.

Housing provided by Housing NSW and community housing providers is very similar. They both offer secure, affordable, long-term rental housing for people on low incomes who need a home, but community housing is generally managed by not-for-profit organisations. The homes are either owned by the government or

rented from private landlords with government funding.

Community housing providers have similar policies to public housing but there are some key differences:

- some community housing providers allow their clients to select more than one location when applying for housing
- the length of lease (tenure) offered can vary. Some community housing providers offer continuous leases unlike public housing who offer 2, 5 or 10 years depending on your circumstances.
- some community housing providers may charge a small bond at the start of your tenancy.

If you would like further information or have specific questions you will need to check with the particular provider in your area.

Who are the participating community housing providers?

There will be one or more housing providers offering housing in most towns and all cities and major centres in NSW. We have included a list of participating community housing providers in this information sheet or you can contact your local Housing NSW office for further information.

There are some areas in NSW that will only have properties that are managed by community housing providers and there may be some areas where there is only public housing available.

I'm currently on the waiting list with Housing NSW. What does this mean to me?

Your application will now be transferred to the new NSW Housing Register, which can be accessed by Housing NSW and participating community housing providers. Your personal information (including health

information) could be shared between participating housing providers during this transfer process to make sure all your information is transferred smoothly.

Setting up the new NSW Housing Register means Housing NSW and participating community housing providers will no longer need to maintain their own separate waiting lists.

From 27 April 2010 your personal information (including health information) will be shared between participating housing providers so your application for housing can be processed and assessed. Your personal and health information is still subject to the same level of protection under privacy legislation as it is now.

However, you can only be made offers of housing by participating community housing providers if you have already told us you wish to be considered for community housing.

If you are not sure whether you have done this, or you want to make this change to an existing application, please contact your local Housing NSW office and they will help you do this.

Who will look after my application for housing and my future housing needs?

For your convenience, after 27 April 2010 you are able to contact any Housing NSW office or a participating community housing provider to request any changes to your application. This might be as simple as a new contact number or a change of address.

Where do I go when I have a change of circumstances?

After 27 April 2010, Housing NSW or a participating community housing provider can update your application with a change of circumstances. For example, if your application was originally lodged with Housing NSW but it is more convenient for you to visit a participating community housing provider office, then you can advise the community housing provider about your change of circumstances.

Will I have more opportunities to be housed if I register interest in both public and community housing?

Yes. There are more opportunities to be housed when you have registered your interest in public and community housing. It is very difficult to tell which housing provider will make you an offer as it depends on many factors like:

- the availability of properties to be offered from public housing and community housing in the area of your choice
- the number of people on the NSW Housing Register that applied for public housing or for community housing in that area.

What changes after 27 April 2010?

Now

You have applied for housing assistance with Housing NSW and several community housing organisations.

If you want to update or change your details, or you want to know where your application is up to, you need to contact each provider separately.

From 27 April

You will be able to contact **any** Housing NSW office or participating community housing provider to:

- request any changes to your application (eg. new contact number or a change of address)
- find out where your application is up to
- request a transfer.

For example, if your application was originally lodged with Housing NSW but it is more convenient for you to visit a participating community housing provider office, then you can advise the community housing provider about your change of circumstances.
